**SUBJECT: IMPORTANT CIRCULAR REGARDING SUBMISSION OF BI-ANNUAL 2021 AND BHASKAR 2021 FORMS AND OTHER GENERAL INSTRUCTIONS.**

1. The Bi-Annual 2021 as well as Bhaskar 2021 examination forms can be submitted till the end of July 2021 i.e till 31/7/2021. This date is subject to COVID situation in the country at that point of time and can be extended in case required.
2. Examination fees of Bhaskar Part 1 and Bhaskar Part 2 as well as certificate fees of Visharad Final, Bhaskar Part 1 and Bhaskar Part 2 have been enhanced and therefore the enhanced examination fees which is inclusive of certificate fee shall be deposited with the examination forms. The amount of the enhanced fees can be seen in the new examination form on Kendra's website i.e [www.pracheenkalakendra.org](http://www.pracheenkalakendra.org)
3. For Bhaskar candidates, copy of self attested Aadhaar card is to be attached with the examination forms.
4. While submitting TA/DA bills, please give correct and clear account details and it would be much better if a copy of the cancelled cheque containing account number , IFSC code , Bank details , is attached with the TA/DA .

Following are the cell phone numbers of the Zone Incharge/s so that the centre holders can contact them directly in case of any query or issue with regard to examination etc. However , it is requested and required that the Zone Incharges shall be contacted on telephone during office hours only i.e between 10:00 am to 5:00 pm and should not be disturbed after office hours except in case of any emergency. Further , as per the current practice , the centre holders can also contact the other senior officials at Chandigarh/Mohali office as well as Kolkata Zonal office and other Regional offices of the Kendra, as per the requirements.
