No examination form(s) after these dates will be entertained unless a special permission is sought from the Registrar or any other authorized official of PRACHEN KALAKENDRA, CHANDIGARH. but in any case of examination form will be accepted after **15.09.2021** any circumastances. Due to Covid-19 situation, no late fee is being charged this year.
- 2. This year due to the special circumstances arisen on account of Pandemic, COVID-19, the examination shall be held as per the Government instructions and in compliance with the guidlines issued by the concerned Government Authorities from to time including Ministry of Home Affairs, Ministry of Health, various State Governments and the Central Government.
- 3.
