Subject :- 1. Submission of examination forms for the Annual Examination Session 2021-2022

2. Date-Sheet for the Annual Session 2021-2022.

Dear Sir/Madam,

It is brought to your kind notice that the Annual examination for the year 2021-2022 will be held on **26th & 27th February 2022** and the last dates for the submission of examination forms of the said session have been fixed as under:-

1. That the dates for submission of examination forms will start from **1/11/2021 and will end on 31/12/2021.**
2. That however in case of a reasonable and sufficient ground for delay is made out and after approval from the Additional Registrar, Head office and Senior Assistant Registrar/Controller of Examinations /other authorized person in this behalf, the examination forms can be submitted till **15.01.2022.**
3. That however under exceptional circumstances and unless a special permission is sought from the Registrar Pracheen Kala Kendra, Chandigarh, examination forms can be submitted after 15.01.2022 **but only till 30.01.2022 but in any case no examination form will be accepted after 30.01.2022 under any circumstances. DUE TO COVID-19 SITUATION, NO LATE FEE IS BEING CHARGED THIS YEAR ALSO.**
4. **The examination forms can be submitted through post as well as personally in the head office, zonal office and regional offices of the Kendra, as the case may be.**
5. **Examination** forms till the date 15.01.2022 must be sent directly by post to Chandigarh/Mohali office and not to Kolkata zonal office/regional offices to avoid unnecessary delay in issuing roll nos to the students appearing in the various grades of examinations. However, subject to **instructions 1 to 4 above**, under special /exceptional circumstances the examination can also be send/ submitted / deposited personally by hand at the head office / zonal office / regional office upto 31.01.2022 with special permission as mentioned above.
6. The examination forms will be accepted only if they are accompanied by the requisite fee. The examination fee should be sent through Bank Draft /RTGS/NEFT in favour of Pracheen Kala Kendra, Chandigarh. The bank account of PKK is available on the website of the Kendra. Under Special circumstances, the examination fee can be deposited at Zonal Office /Regional offices against a proper and duly issued receipt and only after getting prior permission from the Head office.
7. All the important instructions mentioned in the examination form are also applicable as it is **AND ARE TO BE FOLLOWED STRICTLY.**
8. The examination forms already dispatched must have been received by now. If not, please let us know per return of mail so that immediate action could be taken in this behalf. In case you require more forms, kindly inform us immediately so that needful could be done without any delay.
