## **Rates of T.A. and D.A. admissible to Practical Examiners**

1. Prarambhid Part I to Sangeet Visharad Final (Elementary to 5<sup>th</sup> year) Six actual 2<sup>nd</sup> class rail fares inclusive of all incidental Charges.

Or

Six actual ordinary bus fares inclusive of all incidental charges where the distance by road is shorter as compared to the distance by rail.

2. Sangeet Bhaskar Part I & II (6<sup>th</sup> & 7<sup>th</sup> year) Two First Class fares inclusive of all incidental charges.

Or

Six actual ordinary bus fares or three deluxe bus fares where the distance by road is shorter as compared to the distance by rail.

### **DAILY ALLOWANCE**

3. Prarambhid Part I to Sangeet Visharad Final (Elementary to 5<sup>th</sup> Year) Rs. 80/- per day of the actual Practical Examination days (No daily allowance is permissible for journey day/s).
4. Sangeet Bhaskar Part I to II (6<sup>th</sup> to 7<sup>th</sup> year) Rs. 100/- per day of the actual Practical Examination days (No daily allowance is permissible for journey day/s).
